How do I view Import Conditions

This task card demonstrates how to view Import Conditions after conducting a search in BICON web, to locate a case relating to your goods.

Search and Select a Case

In the **Quick Search** tab, enter the commodity you are wishing to import and select **Search**. Once you have conducted a search and reviewed the search results, select the required case.

This case describes the requirements for the importation of dairy products. Dairy may include products such as cheese, butter, milk based infant formula, chocolate, lactose and its derivatives, clarified butter oil, ghee, milk products, colostrum, yoghurt, ice cream, cream, milk protein, casein and whey. Please note that this case only applies to the dairy component of composite products. If you are importing a composite product, you must search BICON for each individual ingredient to determine the conditions that apply.

Import Questions and Defining an Import Scenario

Defining an import scenario is the process of answering questions about the goods you would like to import, after selecting a case. The questions will determine the specific import conditions for your goods.

View Import Conditions

The **Import Conditions** will provide you with the information you need to import your goods, including Warnings and Information Notices, whether an import permit is required, and other documentary requirements.

If an import permit is required, an Apply Now button will be presented.

Ensure you also view the non-commodity case and understand any relevant non-commodity conditions.

TIP: Warnings and Information Notices might draw your attention to any other agencies you may need to notify or contact about your import.

Import Conditions		
Import conditions define the biosecurity requirements which must be met for your import. Where import conditions have been developed, they will be listed below.		
List of countries approved as free from foot and mouth disease #.		
a. A Department of Agriculture, Fisheries and Forestry import permit is not required, provided that the following conditions are met.		
b. The goods must meet biosecurity requirements.		
To demonstrate compliance with this requirement you must present the following on a Manufacturer's declaration or Food product label:		
Evidence that the goods were manufactured in a country approved by the Australian Director of Biosecurity as free from foot and mouth disease (list of countries approved as free from foot and mouth disease #).		
c. If documentation is unable to be provided, or the documentation is insufficient, then the goods will be inspected to ensure that they comply with the conditions.		
d. The goods must be <u>commercially prepared and packaged</u> .		
e. The goods must be imported for personal use.		
A consignment is considered to be imported for personal use if the goods are:		
1. up to 10 kilograms of solid food, or		
2. up to 10 litres of liquid food.		
These limits apply per passenger or consignment.		
Commercial samples (of any quantity) and goods imported in quantities greater than those listed above must be imported under the non-personal use conditions.		
f. These goods or any derivatives must not be distributed, sold or used for:		
1. animal consumption 2. environmental purposes (including use as bioremediation product or fertiliser) 3. growing purposes, or 4. veterinary therapeutic use.		
g. The goods must be clearly identifiable.		
h. If you are unable to meet the above import conditions and you believe that the biosecurity risk of your goods can be managed in an alternative way, you may apply for an import permit which will be assessed by the Department of Agriculture, Fisheries and Forestry prior to the importation of goods into Australia.		
Note that an import permit will only be issued if biosecurity risks can be managed to an acceptably low level. You will need to provide information with your permit application to demonstrate equivalence with the conditions outlined above.		
An import permit may be obtained by submitting an import permit application to the department (use the 'Apply Now' button at the bottom of this page).		
To apply for an import permit you must complete an application for Butter and cheese from countries free from foot and mouth disease Apply Now
